Donation Funds

Any donation will be placed in the General fund and used as the Trustees of the CIO see fit to further its aims.

Gift Aid

Using Gift Aid means that for every pound you give, the Northampton & Lamport Railway CIO will receive an extra 25 pence from the Inland Revenue, helping your donation go further.

This means that £10 can be turned into £12.50 just so long as donations are made through Gift Aid. Imagine what a difference that could make and it doesn't cost you a thing!

To qualify for Gift Aid, what you pay in income tax or capital gains tax must equal or exceed the amount the charity will claim in the tax year. If you are a higher rate taxpayer, you will also be able to claim a tax relief through your tax return.

Data Protection Act

Membership Subscription Renewals

Annual membership subscriptions are renewable at the end of the anniversary quarter of the initial payment.

Volunteer Working Membership

Prospective volunteer working members are advised that a passport sized photograph is required for the issuance of a Staff Identity Card.

Volunteer members should bring their Volunteer Working Member / Staff Identity card with them at all times whilst working at the railway.

Membership of the Northampton & Lamport Railway CIO is a prerequisite for volunteering/working at the Northampton & Lamport Railway.

Note: There are no additional membership subscription fees for being a volunteer/working member.

At first it is best to come along on a Sunday from about 09:30 onwards to join in the activities to get a taste of all the departments' activities. No experience needed as necessary training will be provided as required. To work anywhere at trackside, you must have safety footwear and the orange Hi-Viz vest or clothing is compulsory. All such volunteers also need to be trained to PTS standards (personal track safety) – regular training sessions are available.
